Nelson Off-Road Racing Club is proud to be hosting the **2018 Ruff N Tuff 250**. Round 3 of the 2018 ORANZ Championship Series and the Second Round of the Southern Series on Saturday the 12th of May. A one day Enduro race.

Racing will be held at Spooners Forest. It will be signposted from Wakefield. **NO** dogs are permitted in the forest.

A Food cart will be at the event with food and drink available for purchase. EFT-POS available.

Saturday 12th May

Scrutineering will be held at the race venue between 8am and 10:30am.

Scrutineering order

Note: if you do not go through scrutineering in the correct order, you will be turned away.

1. Drivers and passengers to sign in, complete all paperwork and get arm bands put on
2. Get race attire checked
3. Put race gear on, and take vehicle to be checked. At this point you must stay in your vehicle while the check is taking place.
4. Go straight to time trial – 1 timed lap.

As per ORANZ rules, **NO 2018 tag, NO race**. Vehicles to be tagged prior to the event. No tagging of race vehicles will be done at Scrutineering.

As this is an Enduro Event, two fire extinguishers must be carried, along with a safety triangle and a food pack.

The Nelson club recommends arm restraints or nets.

The event will be a timed event with staggered starts for safety reasons.

8:00-10:30am	Scrutineering and time trials
10.15	Kiwi trucks drivers briefing
10.30-11am	Kiwi trucks race
11:00am	Drivers briefing
11:30am	Racing begins

Grid positions for the enduro will be determined by your time trial lap time.

Prizegiving

There will be trophies for 1st, 2nd, 3rd overall and classes depending on numbers.
